Support Summary and Application Forms

This guide is intended to assist applicants with selecting the correct form depending on individual circumstances. Please read the COVID Schemes Guidance for full details on qualifying criteria, limits of payments etc. to ensure you fully understand the benefits payable under the schemes. The schemes are all active until 30 September 2022.

Self-Employed Individuals - Includes sole traders, partnerships and casual works

Income Support Supplement Scheme

For those who have experienced a reduction in sales and earnings on account of the Virus (for example, because of a decline in orders or where they have been required, on account of the Virus, to self-isolate or to quarantine after returning from medical treatment overseas.

Carers Responsibility Supplement

For those not able to work, because they have caring responsibilities which have arisen because COVID-19 has led to the temporary closure of a school or nursery.

Covid Positive Supplement (Individual)

For those not able to work because they have tested positive for the Virus.

Covid Positive Supplement (Dependant)

For those not able to work because they have sole or primary caring responsibility for a dependant who has tested positive for

Employees/Employers

Job Retention (Furlough) Scheme

Applies to each employee (**Employee**) whose employer (**Employer**) is unable, on account of the adverse economic effects of the Virus, to provide them with any work of the type they ordinarily undertake (for example, because that work has declined in volume or because the employee has been required, on account of the Virus, to self-isolate or to quarantine after returning from medical treatment or essential training overseas and is not available for work as a consequence). In those circumstances, the employer may request them, and they may agree, to take a temporary leave of absence from their employment for the Furlough Period

Carers Responsibility Supplement

Applies to each employee (Employee) who is unable to work (either in their normal place of work or from home) because they have caring responsibilities which have arisen because COVID-19 has led to the temporary closure or reduced capacity of a school or nursery.

Covid Positive Supplement (Individual)

Applies to each employee who is unable to work (either in the normal place of work or from home) because they have tested positive for the Virus.

Covid Positive Supplement (Dependant)

For those not able to work (either in their normal place of work or from home) because they have sole or primary caring responsibility for a dependant who has tested positive for the Virus

Business Grant Scheme – Scheme Term May 2020 – 30 September 2022

For businesses who have experienced a significant fall in revenues and profits due to the Virus by providing a grant to cover qualifying fixed costs.
