Constitution (SI 2008/2846) *section 84*

Police Ordinance 2000 *section 4*

Appointment of Chief Police Officer

Electricity Supply Regulations 1969
regulation 10A

Variation of electricity price

1. This notice is given in accordance with regulation 10A(5) of the Electricity Supply Regulations 1969.
2. A variation in electricity prices was announced on 15 March 2022 and comes into effect on 1 April 2022.
3. The overall price of electricity per unit for all consumers is increased from 23p to 25p.
4. For consumers supplied via pre-payment meters, electricity is supplied at 25p per unit and cards are now being sold at above face value.
5. For all other consumers, electricity is supplied at 25p per unit.
