Currency Ordinance 1987 section 10(1)

#### Calling in of one pound (£1) coins

1. With effect from 30 June 2023 circular  $\pounds 1$  coins cease to be legal tender in the Falkland Islands.

2. To assist with the calling in process any person in possession of any of these coins who would like them to be exchanged is asked to present them at the Standard Chartered Bank before 30 June 2023.

3. Please note that the coins can continue to be exchanged after 30 June 2023 but the Commissioners of Currency may levy a handling charge on any coin presented for exchange more than 5 years after the coin has ceased to be legal tender, that is from 30 June 2028.
