### **Retail Prices Index**

The Retail Prices Index for the quarter ended 31 March 2023 has now been completed.

The Index has decreased by 1.0% to 120.460. The change in the Index over the year to 31 March 2023 has been +8.8%.

The data points to a moderation in price growth compared to previous quarters; much of the year-over-year growth is attributed to sustained and substantial price growth in fuel (including vehicle fuel and power), in addition to 'food and non-alcoholic beverages' price increases.

Evidence of inflation in the 'food and non-alcoholic beverages' category is again observed for quarter 1 of 2023, contributing +0.5% to quarterly inflation and +2.3% to annual inflation; and continuing the trend witnessed over the past year. Moreover, the quarterly and annual gains in this category are similar to the growth seen in quarter 4 of 2022.

'Communication' contributes 0% to quarterly inflation and -0.2% to annual inflation. This again reflects the broadband unit price decrease in terms of cost per gigabyte, following the 50% increase in broadband packages introduced by Sure South Atlantic Limited on 1 December 2022.

Moving in tandem with the recent global commodity price trends, the price growth recorded in 'fuel and power', appears to have moderated. It contributes -1% to quarterly inflation and +5.5% to annual inflation. (Note that vehicle fuel is recorded under 'transport', rather than 'fuel and power'). Electricity price growth contributed +2.2% to annual inflation, compared with +2.3% in the final quarter of 2022 while the quarter-on-quarter growth remained unchanged in quarter 1 2023. Specifically, the increase in kerosene price contributed

-1.0% to quarterly inflation and +3.1% to annual inflation (note that this contributor in quarter 4 2022 came in at 4.2%). Both kerosene and diesel prices (year-on-year) continued to rise, although less sharply than observed in the previous quarter while these two sub-indexes (quarter-on-quarter) edged into negative territory in quarter 1 2023..

**Public Health Ordinance 1894**  
*section 44*

**Department of Health and Social Services - Notice of fees and charges with effect from 1 July 2023**

**1. Date the changes have effect**

This Notice has effect from 1 July 2023.

**2. Medical care and medical evacuation**

**2.1 Approved charges**

For the purpose of section 44 of the Public Health Ordinance 1894 ('the Ordinance') the approved charges for medical care and medical evacuation are set out in Schedule 1 to this Notice.

2.1.1 Part A of the Schedule lists the approved charges for which any person who receives medical care of a description in the first column is liable.

2.1.2 Part B of the Schedule lists the approved charges for which persons who receive medical care of a description in the first column are liable except:-

- (a) persons who are 'exempt persons' (see paragraph 2.2); and
- (b) persons to whom the reciprocal agreement applies (see paragraph 2.4).

2.1.3 Part C of the Schedule lists the approved charges for medical evacuation. Everyone who is evacuated from the Falkland Islands for medical reasons is liable for these charges except exempt persons.

**2.2 Exempt persons**

In exercise of the powers in section 44(4) of the Ordinance, the Governor has exempted from the approved charges persons

whose place of ordinary residence is the Falkland Islands at the time the medical care is provided and who:-

2.2.1 are Falkland Islanders within the meaning of the Immigration Ordinance 1999;

2.2.2 have leave to enter the Falkland Islands under sections 9(3), (4) or (5) of the Immigration Ordinance 1999 (diplomats, the Governor, UK civil servants, serving members of UK armed forces and their dependents);

2.2.3 have leave to enter the Falkland Islands under section 15 of the Immigration Ordinance 1999 (refugees etc.); or

2.2.4 have:-

- (a) a permanent residence permit;
- (b) a work permit and section 44(2)(e) of the Ordinance does not apply;
- (c) an accompanying dependent permit and section 44(2)(f) of the Ordinance does not apply;
- (d) a dependent permit; or
- (e) a carer permit.

**2.3 Requirement for health insurance or an employer indemnity**

2.3.1 Holders of visitor permits, volunteer permits, work permits for 9 months or less to which regulation 16(5) of the Immigration (General) Regulations 2021 applies or any other permit issued under the Immigration Ordinance 1999 that is conditional on having health insurance must have health insurance (within the meaning of the Immigration (General) Regulations 2021).

Any person to whom paragraph 2.3.1 applies must provide details of their health insurance or other evidence of the ability to pay the approved charges before medical care is provided.

2.3.2 Employers of seafarers and aircrew who, in the course of their employment, have leave to enter under section 9(1) (shore leave for seafarers etc) or 14 (entry in emergency) of the Immigration Ordinance 1999 must provide an indemnity in respect of the approved charges for which their employees may become liable under this notice before medical care is provided.

The indemnity may be provided by a local agent on behalf of the employer.

2.3.3 In relation to a work permit holder working for an employer who has a contract with the UK Ministry of Defence ('MOD'), the employer is liable to indemnify the work permit holder for approved charges in accordance with contractual arrangements with MOD.

**2.4 Reciprocal agreement**

The approved charges for medical care do not apply to any person to the extent that person would be entitled to receive such medical care under the UK National Health Service free of charge. Medical evacuation is not within the scope of the reciprocal agreement.

**2.5 Waiver of charges**

The Governor in Council has discretion to waive all or a part of the approved charges. Discretion will usually only be exercised in cases of real hardship.

### 3. Testing food and drink

For the purposes of section 13A of the Ordinance the charges for public health testing of food and drink carried out at the request of a person wishing to sell food and drink for human consumption are £65.80 for the actual inspection to be carried out and £40.00 per test with the exception of Legionella detection and enumeration tests which are £80.00 per test.

### 4. Ship sanitation

For the purposes of regulation 32 of the Public Health (Ships) Regulations 2010, with effect from 1 July 2023 the charges under regulation 31 of the Regulations for inspection of a ship in connection with the issue of a Ship Sanitation Certificate are £620.00.

### 5. Health records

For the purposes of section 3(4) of the Access to Health Records Ordinance 1995, with effect from 1 July 2023 the

charges for providing a copy or extract of a health record are listed in Schedule 2. The cost of postage (if applicable) may be charged in addition.

### 6. Other services provided by King Edward Memorial Hospital

With effect from 1 July 2023, other services provided by King Edward Memorial Hospital ('KEMH') that are not medical care provided under Part IV of the Ordinance are charged in accordance with Schedule 3.
