#### **Retail Prices Index**

The Retail Prices Index for the quarter ended 30 June 2023 has now been completed.

The Index has increased by 1.1% to 121.741. The change in the Index over the year to 30 June 2023 has been +9.5%.

After the noticeable moderation in the Index inflation readings during the first quarter, inflation surprised to the upside and remained stubbornly persistent in quarter 2 of 2023. Much of the quarterly and year-over-year growth is attributed to sustained and substantial price growth in fuel (including vehicle fuel and power), in addition to food and non-alcoholic beverages. Furthermore, the effects of those increases are aggravated by a surprise uptick in the cost of 'recreation and culture' during the second quarter.

Evidence of inflation in the 'food and non-alcoholic beverages' category is again visibly obvious for quarter 2 of 2023, contributing +0.8% to quarterly inflation and +2.7% to annual inflation; and continuing the trend witnessed over the past year. Interestingly enough, the quarterly and annual gains in this category are higher than the growth seen in quarter 1 of 2023.

As a result of the recent decline in a range of commodity prices, the price growth recorded in 'fuel and power', continues to have remained steady. It contributes -0.1% to quarterly inflation and +5.3% to annual inflation. (Note that vehicle fuel is recorded under 'transport', rather than 'fuel and power'). Electricity price growth contributed +2.0% to annual inflation, compared with +2.2% in the first quarter of 2023 while the quarter-on-quarter growth remained unchanged again in quarter 2 of 2023. Specifically, the increase in

kerosene price contributed 0% to quarterly inflation and +3.4% to annual inflation (note that this contributor in quarter 1 of 2023 came in at 3.1%). The kerosene sub-index (year-on-year) edged up slightly again, although less sharply than seen in the last quarter of 2022. Significantly, the diesel sub-index (year-on-year) dipped into negative territory for the first time since quarter 1 of 2021.
