Falkland Islands Constitution Order 2008 *section 84* **Taxes Ordinance 1997** *section 5*

Highways (Weight Limits) Ordinance 2004 *section 6*

Prohibition Notice

In exercise of the powers provided under section 6(4) of the Highways (Weight Limits) Ordinance 2004, I hereby notify that the use of any motor vehicle, trailer or vehicle combination the authorised weight of which exceeds 15 metric tons is prohibited with effect from 1 May 2024 until 30 September 2024 inclusive on the following publicly maintainable highways:

(1) on East Falkland:

all roads beyond the Estancia junction as approached on the Port Louis Road from the direction of the Mount Kent turnoff;

the Fitzroy Road from its junction with the Stanley to Darwin Road to its end at Fitzroy settlement;

the San Carlos Road from its junction with the Stanley to Darwin Road to its end at San Carlos settlement;

all roads beyond the North Arm/New Haven junction as approached from the North on the Stanley to North Arm Road, other than the spine road to New Haven;

the Saladero Road from its junction with the Darwin Road to New Haven Road to its end at Saladero settlement;

the Abattoir Road from its junction with the Stanley to Darwin Road to its end at the Abattoir, and

(2) on West Falkland:

all publicly maintainable highways.

Retail Prices Index

The Retail Prices Index for the quarter ended 31 March 2024 has now been completed.

The Index has increased by 0.7% to 124.295. The change in the Index over the year to 31 March 2024 has been +3.2%.

Stanley inflation picked up for the first time since quarter 2 2023. The change in the Index over the year to 31 March 2024 has been 3.2% while the Index has increased by 0.7% on a quarter on quarter basis. The data points to a noticeable acceleration in the pace of inflation compared to the previous quarter. Much of the year-over-year growth is once again attributed to sustained price growth in food and non-alcoholic beverages (albeit slightly less so than in the previous quarter) in addition to the categories of 'transport', 'recreation and culture', and 'restaurants and hotels'. Meanwhile, the bulk of the quarterly growth is attributed to a resurgence in energy and food prices and the relative contribution from both classes look significantly more positive than observed previously.

Among all components, 'food and non-alcoholic beverages' was once again the most notable contributor to the annual inflation during quarter 1 2024. To be more specific, the categories which

caused the largest upward contributions to the annual Index were ‘restaurants and hotels’ (+0.6%), ‘transport’ (+0.6%) and ‘food and non-alcoholic beverages’ (+1.4%). Meanwhile, the largest upward contributions to the quarterly inflation growth were from two divisions, most notably ‘food and non-alcoholic beverages’ (+0.4%) and ‘fuel and power’ (+0.4%).

Energy prices, particularly kerosene, remained sticky in quarter 4. Specifically, after edging into negative territory briefly in the final

quarter of 2023, both quarterly and annual kerosene sub-indexes came in at +0.4% and +0.2% respectively. Electricity price growth continued to contribute negatively (-0.5%) to annual inflation while the quarter-on-quarter growth remained flat during the quarter.
