



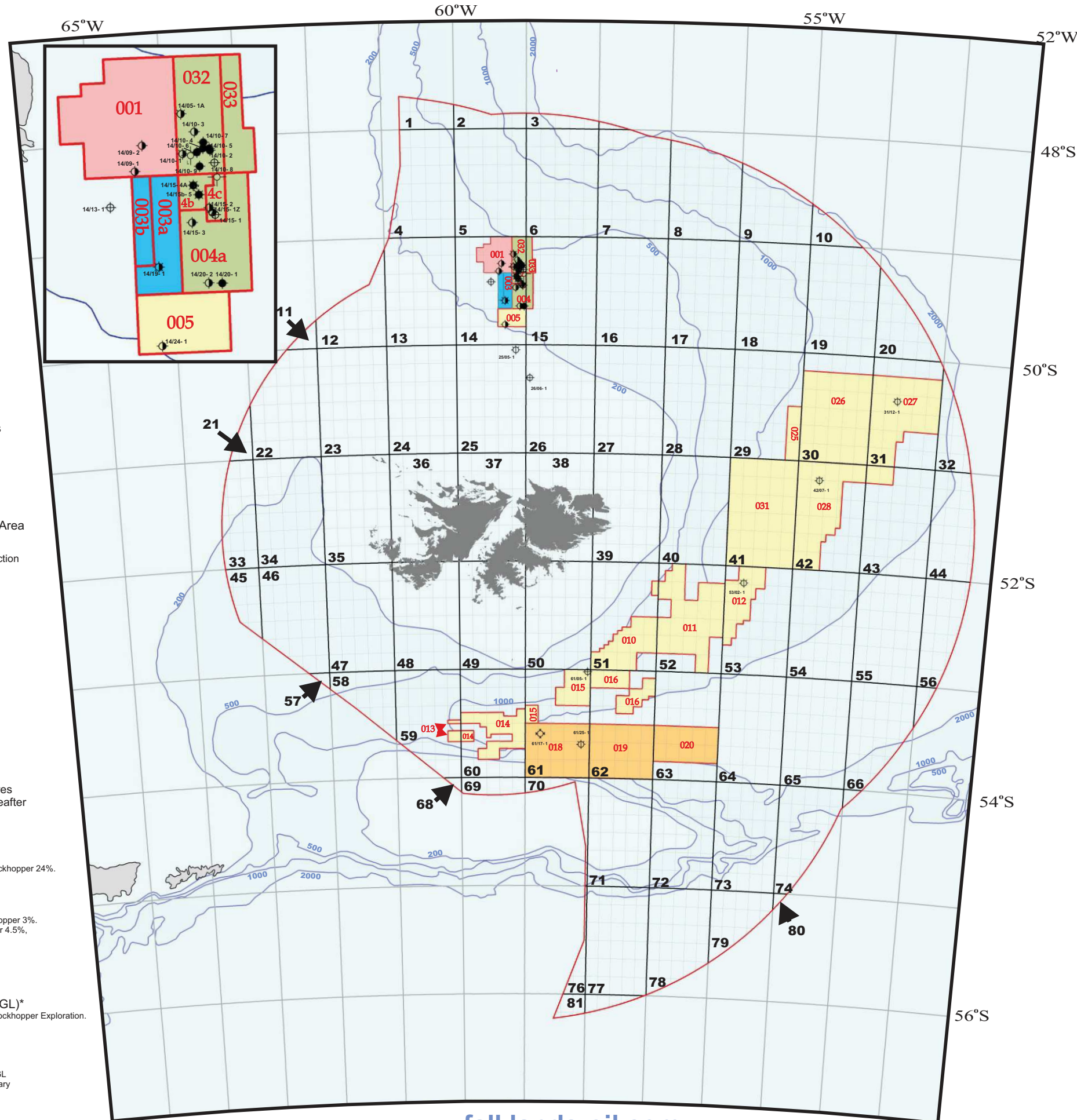

Licence Terms*

Competitive Round Production Licences

1st Phase 5 years (subsequently extended by 3 years). 50% relinquishment of acreage holdings.

2nd Phase 7 years (extendable by a maximum of 5 years depending on additional seismic survey and drilling commitments). 50% relinquishment of acreage holdings.

3rd Phase 10 years, with new drilling commitments.

Exploitation 35 years or longer. Applies to fields only.

Open Door Production Licences

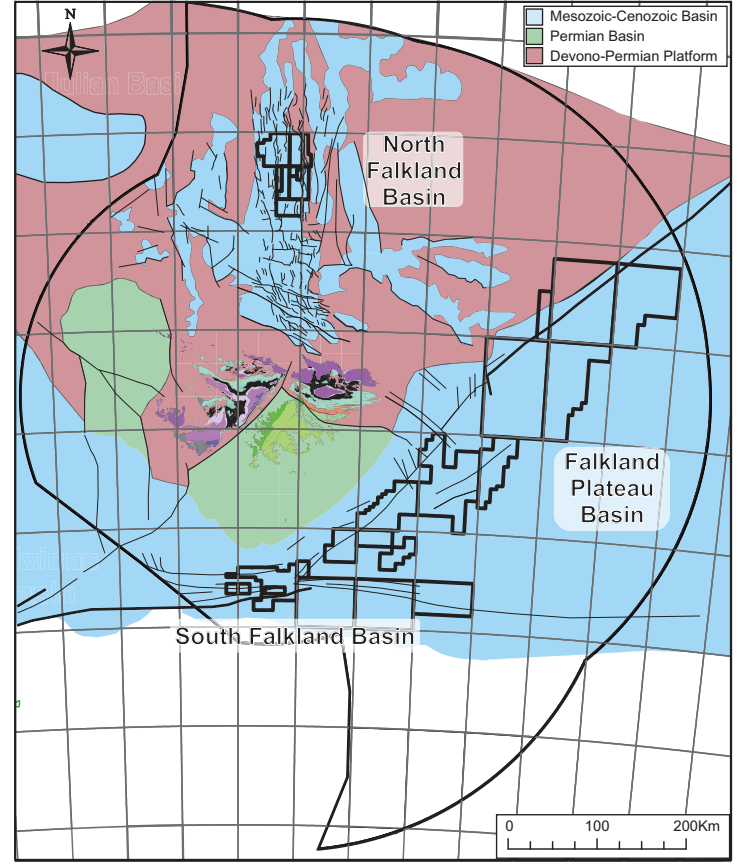
1st Phase From 3 to 8 years (dependent on work programme). 50% relinquishment of acreage holdings.

2nd Phase 5 years, entry subject to drilling commitments (extendable by a maximum of 5 years depending on additional seismic survey and drilling commitments). All acreage holdings except discovery area relinquished.

Discovery Area 5 years for appraisal and development, extendable to 10 years depending on submittal of Field Development Plan or commencement of appraisal drilling.

Exploitation 35 years or longer. Applies to fields only.
